### Now more than ever,

### EveryStep empowers individuals, supports families and strengthens communities.

A true measure of EveryStep's strength and resiliency is how well we have survived — and thrived — when faced with overwhelming changes and challenges. Thanks to your support and the resourcefulness of our staff, we continue to exceed our goals even as we pivot to respond to our community's evolving needs. As we reflect on this past fiscal year, two themes emerge in which we take great pride:

#### **COVID-19 Response**

EveryStep was not unique in being challenged by the COVID-19 pandemic and quickly adapted to continue to provide care and support to those most impacted:

- EveryStep opened a COVID-19 wing at the Bright Kavanagh Center on the east side of Des Moines to serve COVID-19
  positive hospice patients.
- Staff made emergency deliveries of infant and baby items to young, low-income moms.
- Technology was quickly deployed so that telehealth visits and virtual grief and loss support groups could continue to be offered.
- EveryStep partnered with other non-profits to get food and COVID-19 care packages to the those in need.

#### **Expansion of Services**

EveryStep continues to grow even with the challenges presented by the pandemic:

- Grief and loss programs have expanded to include traumatic and anticipatory loss support groups, as well as a school-based support program.
- A record 430 Cheer Boxes were delivered in 2019 to those experiencing the holidays for the first time without a loved one.
- Our home care program grew to 22 counties in the past year with the addition of a new team in Centerville, expanding our service to rural Iowa where the need is greatest.
- The palliative care program we launched in Winterset is being expanded to include Creston.
- Our Senior Companion program has launched a second service area in Pottawattamie County.

This has been a successful year for EveryStep, and it would not have been possible without the ongoing, generous support of our donors. Thank you for investing in our work!

## Adapting and Innovating Our Care

EveryStep is committed to being there when families and individuals need care and support. This has never been more true than throughout the past year.

During this time of crisis, the need for our services has increased while our ability to provide those services has become more difficult. It's times like these that our staff work together to adapt and find innovative solutions to continue delivering vital care and support for our community.

Despite the challenges of the past year, EveryStep served more Iowans than ever before — **67,245** in all.

**HOSPICE & HOME CARE** 

### We cared for **1,741** hospice and home care patients.

From the very begining of the pandemic, EveryStep quickly implemented new protective measures and provided education and training to staff. Nurses and aides were able to continue serving our hospice and home care patients with safe, in-person care while social workers, spiritual care counselors and other staff shifted to phone consultations to continue providing vital services to patients and their families.



STORK'S NEST

### **1,540** women earned \$54,564 in baby and home items.

The Stork's Nest and Family Nest are incentive-based programs that empower low-income mothers, through healthy behaviors, to earn baby items and household supplies. With the closure of the Nest "stores" due to the pandemic, the programs moved to delivering vital items to clients' doorsteps. The need for those items — cribs, mattresses, car seats, diapers and formula — has only grown, as many families have experienced short- or long-term unemployment.



GRIFF & LOSS SERVICES

### We provided **3,054** grief support visits and touchpoints.

The support we provide following the loss of a loved one did not end simply because in-person support was no longer possible. Our hospice program made phone calls to grieving families, and our Amanda the Panda program quickly shifted to online support groups, camps and other virtual activities. Children, families and individuals adapted along with us and were able to continue finding comfort in talking to facilitators and others who are experiencing grief.



**VOLUNTEER SERVICES** 

### More than **700** volunteers gave **69,865** hours of time.

Volunteers play an important role in our hospice care, grief and loss services, and support for seniors. When in-person visits were no longer possible, volunteers began providing support through phone calls, letters and no-contact deliveries of groceries and other necessities. Volunteers have helped our clients and patients remain socially connected, while others found new ways to volunteer such as making masks and other protective equipment for our staff.



INTERPRETATION SERVICES

### **1,637** hours of interpretation services were provided.

Our team of interpreters speak 20 languages and help non-English speakers access health care and other vital services. Because EveryStep was offering remote interpretation (VRI) to areas beyond Polk County, our staff immediately and smoothly transitioned to a remote service model for nearly all clients at the onset of the pandemic.



## Responding to Community Needs

**COVID-19 HOSPICE UNIT** 

### EveryStep offered a way for families to be together.

To address the possibility of medical center overload in Iowa, EveryStep equipped a wing of the Bright Kavanagh Center on the east side of Des Moines to serve COVID-19 hospice patients during the surge of cases in spring 2020. Sufficient protective equipment was available for patients to have two visitors once a day, allowing families to be together at the end of life. This unit was the only facility in the state solely dedicated to serving dying patients with COVID-19.



CHILD CARE NURSE CONSULTANTS

### **246** childcare providers were served by our CCNC nurses.

Childcare providers throughout Polk and Dallas counties rely on our team of child care nurse consultants for expert guidance. This past year, those providers looked to EveryStep as their primary source of information during the pandemic. We helped their staff navigate the complex protocols issued by state and local agencies in order to keep staff, children and families safe and to keep daycare facilities open.



HEI PING COMMUNITY PARTNERS

### When our community needed us, we answered the call.

With the onset of the pandemic, our staff began operating in very different ways, leaving our vehicles and some staff available to assist other non-profits. When United Way of Central Iowa and WesleyLife needed help making deliveries for the Meals on Wheels program, EveryStep stepped up. Our staff also began distributing COVID-19 care packages to vulnerable populations on behalf of John Deere and UnityPoint Health.



# Growing and Evolving

HOME CARE EXPANSION

### EveryStep provided home care to **562** people in **22** counties.

With demand growing for quality in-home care, EveryStep opened a third home care office in fall 2019, expanding that service to 22 counties. Teams located in Des Moines, Creston and now Centerville serve central and southern Iowa, helping people recover from illness, injury or hospitalization within the comfort of their homes. EveryStep will continue expanding the home care service area in the coming year to meet this ever-growing need.



PALLIATIVE CARE

### We're helping to improve quality of life for all.

With financial support from Telligen, EveryStep launched a new palliative care program in Winterset to offer an extra layer of support for individuals living with serious, complex or chronic illness. In partnership with Madison County Hospital, the program offers comfort and quality of life as well as expertise in helping patients and families navigate complicated healthcare decisions. EveryStep is also working with Greater Regional Medical Center to expand service to the Creston area.



SENIOR COMPANION PROGRAM

### **311** seniors received support from Senior Companions.

The Senior Companion Program, which serves older adults in Lucas, Marion, Polk and Warren counties, expanded this year to include Pottawattamie County in western Iowa. Senior Companions help homebound seniors by providing companionship, rides to appointments, delivery of items and help with other tasks. Ninety-three percent of clients report they are better able to remain living independently with help from their Senior Companion.






